**Ramps at the sole discretion of the judge**, approved breeds may be judged on the ground or on a ramp: Boykin Spaniels, Clumber Spaniels, Field Spaniels, Sussex Spaniels, Welsh Springer Spaniels, Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Chinese Shar-Pei, Chow Chows, Keeshonden, Norwegian Buhunds & Polish Lowland Sheepdogs. (Boykin Spaniels & Whippets may be judged on the table, ramp or the ground.)

Basset Hounds & Bulldogs are expected to be judged on the ramp during breed judging.

This list may be revised from time to time, and the current list can be found on the AKC website in Judging Operations.

A judge requesting the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required.

**Ramps may be used** in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

The club will provide a special Crate/Grooming Tent for the use of all exhibitors bringing their dogs in crates or carrying cases. The tent is arranged in aisles and work spaces, permitting quick access to rings. The Committee asks the cooperation of all exhibitors in accepting assignments and arranging work tables. Crates and tables will not be allowed in the aisles. Grooming tables in excess of 24 x 36 inches will not be permitted. Toy Breeds will be assigned a corner ring. CRATES CANNOT BLOCK EXITS OF TENT PER FIRE MARSHAL. **Exhibitors MUST** be governed by any rules or regulations of civil authorities, building and parking restrictions. Vehicles parked contrary to regulations will be subject to towing at the owner's expense.

The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is expressly understood that exhibitors will exercise control and restraint over their children on the day of the events.

NOTE: THERE ARE TWO (2) RESTROOM FACILITIES BESIDE CONFORMATION JUDGING: One Behind the Club/Superintendent's Tent & One Beside the Food Concession.

All Regular Classes are divided by sex and are offered for all breeds or varieties of breeds unless otherwise noted below. Where classes are further divided by color, weight, or other breed characteristics, it is so indicated below and the class division MUST be indicated on the entry form.

#### Amateur-Owner-Handler Class (effective as of 1/1/2009)

Chapter 3, Section 7 - The Amateur-Owner-Handler Class shall be for dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13).

#### Non-Regular Classes Involving Single Dog Entries FOR VIZSLAS (FRIDAY & SUNDAY) ONLY

NR1.08100.15000. Veteran Classes - Class for dogs & class for bitches seven (7) years & over. Veteran Class winners may compete for Best of Breed if otherwise undefeated at this event. Dogs entered in this class must be intact (i.e., cannot be spayed or neutered.)

NR1.08200. Hunting Classes - Class for dogs & class for bitches that have earned an AKC Senior or Master Title. The winners will be eligible for Best of Breed.

NR1.08500. Field Trial Classes - Class for dogs & class for bitches that have placed First, Second, Third or Fourth in a regular stake at an AKC Licensed or Member Field Trial. Field Trial Class Winners may compete for Best of Breed if otherwise undefeated at this event.

#### FOR GOLDEN RETRIEVERS (THURSDAY, FRIDAY & SUNDAY)

NR1.08100.27400. Veteran Classes - Class for dogs & class for bitches eight (8) years & over. Veteran Class winners may compete for Best of Breed if otherwise undefeated at this event. Dogs entered in this class must be intact (i.e., cannot be spayed or neutered.) (NOTE: Spayed & neutered veteran dogs (bitches) can be shown at the afternoon Hudson Valley Golden Retriever Club Concurrent Specialty - P.M. Judging - See the seperate Premium List.

NR1.08200. Hunting Classes - Class for dogs & class for bitches that have earned a Junior, Senior or Master Hunter Title under AKC Rules.

NR2.09100. Stud Dog Class - For Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of Get. Get only to be judged based on the merits of the Get. Get MUST be entered in one of the Regular Classes. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed.

NR2.09200. Brood Bitch Class - The same as Stud Dog except substitute Brood Bitch for Stud Dog & Produce for Get.

As the judges' decision in the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed or Variety by virtue of having won these classes.

Immediate family is defined as husband, wife, mother, father, brother, sister, son, daughter or legal domestic partner. Step children and legal wards are also included this definition. In-laws and grandchildren are not considered to be immediate family members. No other individual may take the entry into the ring during judging or check-in.

The following individuals are excluded from showing an exhibit in Sweepstakes unless they are the sole owner regsitrered with the AKC or co-own the entry with a member of their immediate family (as defined above) or a legal domestic partner:

- Any individual listed as an agent on any dog in any regular or non-regular class at this or any other show in the
  previous two years.
- Any individual with an Agent Number including, but not limited to an AKC Registered Handler Number or Professional Handlers Association (PHA) number.

To avoid confusion or question, it is recommended that a photocopy of the registration certificate be included with the entry for a co-owned exhibit.

**BEST IN SWEEPSTAKES CLASSES:** It is required that the same person who showed the dog to a first place in a Sweepstakes Class will also show the dog in the Best in Sweepstakes Classs. 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
