ABOUT RETURNED CHECKS: The trial secretary will not return checks for entries that are not accepted or entries cancelled by the competitor before the closing date and before the check has been deposited. All unused checks will be shredded. All entries must be accompanied with a check to be valid. A returned check is not a valid entry. A Returned Check for insufficient funds will be charged an additional \$25 fee.

Fast CAT events are open to all dogs at least 12 months of age that are registered with the AKC, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration and dogs enrolled in the AKC Canine Partners program on the day of the trial. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate.

If your mix breed dog needs an AKC Canine Partner number a form and information is available on page 5 in this Premium. It is only \$19.

Dogs may only run once per test. All entries must be accompanied with a check to be valid. A returned check is not a valid entry.

Check in & Inspection.

You may check in for inspection 15 minutes prior to the beginning of the trial, or throughout the event. Every dog must pass through inspection before each run. Dogs who miss roll call will be skipped. If you do not check in within one hour prior to the end of the trial closing, we will assume you are absent. No refunds for absent dogs. At inspection, all dogs will be examined for disqualifications. Bitches known to be in season are not to be brought to the

test. At inspection, bitches in season, lame and unfit dogs will be excused with entry refunded.

Hours

Grounds will be available one hour prior to trial hours. Trial will start promptly at 8:00am with workers dogs and until all runs are completed. It is the responsibility of each entrant to be ready with catcher and releaser when their dog is called to the line. Concurrent trials will be in effect. Once your two runs are completed you must leave the grounds.

Prizes

A flat blue ribbon for a passing qualifying run. Rosettes to dogs completing title, as available. Please notify the Trial Secretary in advance if you anticipate completing a title. Please note on the bottom of the entry form.

What is a Fast CAT?

1. Fast CAT is a timed straight 100-yard dash for dogs.

2. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced, and dogs are run individually.

3. Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).

4. Based on the dog's size at the withers a handicap is applied and points are earned:

- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Under 12" = Handicap is 2.0.

5. FORMULA: MPH X HANDICAP = POINTS

6. Titles are earned at specific point levels.

BCAT = 150 points, DCAT = 500 points, FCAT = 1,000 points

FCAT# = Each additional 500 points

*ACCORDING TO AKC RULES; Handlers are not permitted to run with a dog during an official run but must remain either at the start or finish area of the course. Handlers are not to allow dogs to be enticed through the course with anything other than the lure during its official run. NO mechanical devices including whistles, horns, bull horns, or toys including the waving of objects to lure the dog to the finish line. You MAY CHEER and use the dog's name only.

Collar Rules: Dogs may run without a collar or wear any type of collar except choker collars, electronic training collars or head collar. Collars should be snug. Hanging tags pose a safety concern and it is suggested that tags be secured to the collar with tape. Dogs may run muzzled if desired. Clips or rubber bands may be used to keep long hair from falling across the dog's field of vision.

• You are responsible for controlling your dog(s) and children.


